Aaron Antcliff I grew up on a farm near West Branch and was very close to my Grandfather, who suffered with, and recently died from, Parkinson's disease. This was my primary motivation for my life-altering decision to study neuroscience. I can remember taking my first neuroscience course at CMU, and knowing somehow that I was entering a world that I very much wanted to be a part of. The subject was cutting-edge brain research, and my instructor was passionate about each and every aspect that was taught. My professors impressed upon me that anyone, if they were willing to work hard at it, could take part in a quest to ease the suffering, and make a positive difference in their lives through scientific research. I was hooked. Since then, I have been involved with the FNI lab at CMU and have experienced a monumental change in my life. I have taken part in some very exciting research projects, and am continuing to receive world-class education with Drs. Gary Dunbar and Julien Rossignol at the

FNI lab. The FNI Fellowship that I received will allow me to embark on an exciting study in which I will induce ordinary bone-derived stem cells to over-express an important protein that will assist in carrying those stem cells across the blood-brain barrier. These cells will then, hopefully, localize in damaged areas of the brain release other proteins that will assist in the recovery of brain functioning. If it wasn't for the FNI lab, and the FNI Fellowship I have received, I doubt that I would living out my dream to help others through developing new therapeutic approaches to brain diseases. I am immensely proud and honored to receive this first-ever fellowship award from FNI, and I look forward to the continuing education and research experience at this truly first-class and one-of-a-kind laboratory. We truly are at the forefront of research here, and I'm honored to a part of it. Thank you FNI !!!



Tia Hall It is truly an honor to be considered a part of the FNI research family. I can't fully express my gratitude to Dr. Field and the FNI Board members for awarding me the FNI fellowship. Research has become a strong passion of mine; initially sparked by my experience as a nurse aid in the health care field. Working in the medical field opened my eyes to the devastating impact on so many of the families and patients affected by neurodegenerative diseases and disorders, including traumatic brain injury, multiple sclerosis, Huntington's, Parkinson's, and Alzheimer's disease. My desire to help others, to improve the quality of life for people and give them hope, is the prime motivation for my drive to do research. The FNI Fellowship has given me the opportunity to continue looking for potential therapeutic treatments for Alzheimer's disease (AD). The research that I will be conducting centers around observing the therapeutic efficacy of adult-derived stem cells and genetically modified stem

cells in altering some of the neuropathological and behavioral symptoms associated with AD. Specifically, these funds will help me look for ways in which we can prevent the misfolding of proteins that lead to the plaques observed in AD. With the ultimate goal of better understanding this devastating neurodegenerative disease and developing new treatments to counteract it, I strive daily to grow as a neuroscientist and as a person. Once again, I cannot thank FNI for their generous contributions and continual support. Together, we will help find effective treatments or cures for AD.



Cameron Learman It was many years ago that my love for the elderly, especially those living with dementia, ignited. As an activist for those with dementia and their families, I consciously made a decision to make a difference. Volunteering at an adult day care center, instructing exercise programs to those with dementia, and providing direct patient care as a certified nursing assistant within a nursing facility, paved the way. Knowing the risk factors, understanding the myths, the steps to diagnosis, and treatment options is vital in providing education and support to those in need. This is what motivated me to join the FNI labs at Saginaw and at CMU, so that I could conduct research to further our understanding of, and to search for effective treatments for, Alzheimer's disease (AD). My specific research interests came when, while working as a nursing assistant, I became increasingly aware that diabetes was prevalent amongst my AD residents. To further explore this link, I will use the FNI fellowship to study how diabetes, specifically Type II Diabetes Mellitus, is involved with AD, and to evaluate the efficacy of using genetically altered adult stem cells to treat this complicated and

devastating disorder. My dream to make a significant and positive impact on the lives of the elderly through research into the causes of, and treatments for, AD would not have been possible without the generous support of FNI. I would like to extend a heart-felt thank you to Dr. Field and the FNI Board members for awarding me an FNI fellowship. You not only have given me the opportunity to further my education, but you are allowing me to do my part in turning helplessness into hopefulness for those with AD and for their families.


Jacob Dunkerson In 2011 I was accepted into the Masters of Science in Occupational Therapy (MSOT) program at Saginaw Valley State University (SVSU) with an interest in helping patients suffering from the consequences of neurological injury. At about the same time I began working with Dr. Smith in the Brain Research Laboratory (BRL) at SVSU. As I progressed through the MSOT program I found myself frustrated by the lack of options to help those suffering from brain injury, while at the same time learning more and more about how I could perform research to develop therapies that are so desperately needed for the brain injury community. After three years of working in the lab and in the clinic, I have decided that I can help more through science than I could ever help through practicing as an occupational therapist. I have worked on multiple research projects;



one of which has been published and another which I helped design, lead, and have just recently submitted for publication to the Journal of Restorative Neurology and Neuroscience. In both experiments I gained valuable research experience, from basic animal care to independently performing cortical contusion impact surgeries and stem cell transplantations. I have learned how to conduct and analyze multiple behavioral tests, histological procedures, and microscopy techniques. I am currently developing a proposal to perform an additional research project which will combine enriched environment and neural stem cell therapy to treat chronic symptoms of Traumatic Brain Injury (TBI) 30 days post-injury. In order to fund this project, I am submitting a proposal for a grant through the Student Research and Creativity Institute at SVSU.

Last year my father was diagnosed with pancreatic cancer and three months later he passed away. As a result, I am now independently supporting myself by working part-time as a lifeguard at SVSU and as an on-call OT. The funds that this fellowship will provide will allow for me to work less at these part-time positions and focus more on my studies and to continue being active in the laboratory. Though I have completed all requirements for the MSOT, I still need an additional year at SVSU to complete my bachelors degree. Over the next year, I will take additional classes with a focus in neuroscience, biochemistry, and genetics. I will also continue to perform research in the BRL and prepare for the Graduate Record Examination in order to ensure that all aspects of my graduate application are competitive. After I obtain my Ph.D. in neuroscience, my plan is to continue my development through post-doctoral training opportunities leading to a position that would allow me to combine my interests in mentoring with the ability to perform high-level neuroscience research. All of these experiences are preparing me for applying to neuroscience graduate programs across the nation. I have already identified and met with potential mentors at many universities. The experiences I have had at SVSU and the support that this fellowship will provide will lead to opportunities to continue my growth as a neuroscientist.

Garrick Salois During my studies as a psychology major at Saginaw Valley State University, I became fascinated by how behavior arises from changes in the brain. My interest in exploring aberrant brain function led me to volunteer at the Brain Research Laboratory (BRL), headed by Dr. Jeff Smith. Over the past year volunteering at the BRL, I have learned about traumatic brain injury. Despite decades of research in animal models, no consistently effective treatment for traumatic brain injury has been found. One possible reason for this is that animals typically recover from experimentally-induced injury in standard laboratory cages. It has been shown that animals whose recovery environment is enriched with sensory stimuli recover differently than rats in standard caging. To examine this effect, we studied brain-injured rats treated with progesterone and/or



neural stem cells as they recovered in either enriched environments or standard caging. As a student researcher, I was able to participate in all aspects of the project, including behavior testing, histology, and data analysis. The project eventually culminated in a presentation of our work at the Faculty for Undergraduate Neuroscience conference in San Diego and will soon be submitted for publication. Results from this study indicated substantial changes in the hippocampus of injured rats. Detailed morphological analysis of this system is challenging because its relatively large size and high spatial complexity is difficult to preserve using traditional serial section microscopy. However, recent technological advances are making it easier to visualize and quantify detailed morphological changes in relatively vast sections of brain tissue. In October 2013, I won a Saginaw Valley State University Student Research and Creativity Institute grant, allowing me to utilize SeeDB, a new optical clearing technique, in combination with confocal immunofluorescence microscopy, to analyze vascular, neural, and glial changes in the hippocampus, including neurogenesis, following long-term environmental enrichment in rats.

While I work on this project, I am also developing my applications for several PhD programs. With the support of the Field Neurosciences Institute, I intend to take further classes in biochemistry, genetics, and statistics - classes I would not otherwise be able to afford. These skills will allow me to competitively apply to prestigious PhD programs in neuroscience – a key step toward a career as a scientist.

Clinical Research

We are continuing our studies in the areas of Multiple Sclerosis, glioblastoma, and traumatic brain injury, including:

Stratify 2

A Multiple Sclerosis clinical trial: We have 65 subjects enrolled and have started the extension study that will track these patients for 4 more years. The principal investigator (PI) for this study is Barbara Jahnke M.D. The purpose of the study is to quantify the serological prevalence of JCV (John Cunningham virus) antibody in the MS population and give the prescribing physician and patients receiving Tysabri more accurate information of their risk for developing PML (progressive multifocal leukoencephalopathy). The official title of the study is: JCV Antibody Program in Patients with Relapsing Multiple Sclerosis Receiving or Considering Treatment with Tysabri: STRATIFY-2. We have already learned that patients who test positive to the JC virus antibodies, have been on immune suppressants and have more than 24 infusions of Tysabri are at greater risk of developing PML. This study has a new amendment that will now only follow the patients on Tysabri and add 2 additional blood draws per year.

Synapse

This is a randomized trial for patients with a traumatic brain injury. Subjects get randomized to standard of care or to standard of care with the addition of the IV infusion of Progesterone. This study has completed enrollment and the outcome data is currently undergoing statistical analyses.

CDX-110 Vaccine for Glioblastoma

CellDex-110 phase III study has been approved and we are now screening patients. This is the next phase, the phase III part of this research study for the treatment of brain cancer. We are currently in long term follow up in the phase II portion of the study.

Submissive and Massive Pulmonary Embolism Treatment with Ultrasound Accelerated Thrombolysis Therapy (SEATTLE II Extension) This is a new study with the interventional radiologist, Dr. Nakagawa. We are currently in the contracting phase and getting ready to take to the IRB.

In addition to these ongoing clinical research studies, our Research Nurse, Heather Clark, continues to lead the local Multiple Sclerosis Support Group and has been instrumental in bringing the International Multiple Sclerosis Conference to the Saginaw area. This year's conference will be "Caring for the Patient with MS" on October 18th (see page 5 for conference details). The continued involvement by Heather and Dr. Barb Jahnke in MS clinical work and patient care and with their continued involvement with the International Organization of Multiple Sclerosis Nurses provided the basis for Saginaw being selected for this year's conference.





Pre-Clinical Research

Our pre-clinical research productivity continues to exceed the ambitious goals of the five-year plan and the benchmarks established in our strategic plan. Researchers in the FNI at CMU have produced over 15 publications, spanning the complete array of disorders targeted in the 5-year plan (stroke, degenerative disc, Alzheimer's, and Huntington's disease. In addition, initial work on using adult stem cells for treating Parkinson's disease (which was an addition to the focused area on the 5-year proposal) was initiated and has already produced publications. The highlight of the 5-year plan was the FNI-initiated breakthrough on using genetically altered adult stem cells that overexpress brain derived neurotrophic factor to treat Huntington's disease that is now heading for clinical trials in California.

Our new addition to the FNI lab at CMU, Dr. Crusoe Nan, has begun leading FNI researchers in two new lines of research which have been initiated this past year, involving assessing the efficacy of adult stem cells for treating acute and chronic spinal cord injury and stroke.

As this is the last year of the 5-year FNI-CMU collaborative research projects, a presentation of the accomplishments of the funded project will be made, as well as a presentation for future projects if the Board votes to renew this collaboration for another five years.

Work at the FNI lab in Saginaw has been focused on the molecular mechanisms underlying the neurodegenerative processes that occur in AD. Dr. Mee-Sook Song, Austin Clarey, and a team of volunteers have been looking at ways in which potential therapeutic interventions may reduce the plaques found in brain tissue samples from rodent models of AD. Dr. Song has completed a manuscript of this work as is submitting it for publication in a respected, peer-review scientific journal.

Collaborative projects with Dr. Jeff Smith, Dr. Charles Weaver, and Dr. Rosalyn Sweeting at SVSU are still ongoing. Both Dr. Smith and Dr. Weaver have submitted FNI-sponsored research manuscripts for publication in peer-reviewed scientific journals. Solicitation for applicants for FNI Fellowships to be awarded to SVSU students interested in neuroscience has been initiated. In addition, new collaborative


projects between FNI and SVSU researchers are being designed.

Finally, five FNI Fellowships, derived from the proceeds of last year's Fall Fundraiser, have been awarded to Tia Hall, Aaron Antcliff, Cameron Learman, Jacob Dunkerson and Garrick Salios. These funds will be used to help students devote their time to the critically important and therapeutically relevant neuroscience research in the FNI lab at CMU and also at Saginaw Valley State University Brain Reserach Lab, working with Dr. Jeff Smith.





Injury Prevention

- 1. ThinkFirst for Kids and Teens: We have been busy educating in several elementary and middle schools and are on target to educate in 50 percent of the schools in the Saginaw and Bay areas per our strategic plan.
- 2. Caught Being Safe: We distributed 15,000 coupons for the winter campaign and have received several VERY positive comments about this program. We are gearing up to distribute another 60,000 coupons in May for the summer campaign.
- 3. Spinal Cord Injury Resource Group: Bi-Monthly meetings have brought many resources and education to over 20 people. We continue to offer resources to each other as well as providing resources and support to newly injured individuals with physical disabilities.
- 4. As part of the First Merit Grant that was received, we purchased a distracte driving simulator that we will be able to use in our ThinkFirst for Teens program as well as expand our driver education and are hoping to utilize during many community events.

FNI's ThinkFirst Group Awarded Grants

FirstMerit Bank and the Arnold & Gertrude Boutell Memorial Fund awarded a three year, \$57,000 grant to support the ThinkFirst for Kids, ThinkFirst for Teens and Buckle Your Brain programs. This grant will allow FNI to educate more schools and provide more helmets throughout the Saginaw, Bay and Arenac counties. The grant also provided resources to purchase a driving simulator to be used for teen and community presentations. This simulator creates an experience, including the consequences, of driving impaired by alcohol, drugs, and fatigue in addition to being distracted by texting, cell phone use, and peer distractions.

Distracted Driving Simulator


